The awards select the 100 top SMEs on the basis of scores in a unique evaluation format, created specifically to score and rate SMEs across the length and breadth of the country on a single scale. In line with the strategy to groom promising SMEs, the India SME 100 ranking acts as a catalyst to identify promising SMEs and recognises them for eventually becoming large global-oriented companies.

The awards inspire willing and able SMEs that have the potential to be world-class enterprises and offer them the platform to promote themselves to investors and partners to sustain growth.

EVALUATION PROCESS

SMEs would be selected on the basis of both financial and non-financial indicators. While the financial indicators of Growth Performance and Financial Strength would be keenly evaluated, balanced

Arriving at the final rank-
To be eligible for the India SME 100 AWARDS, an enterprise should be an entity engaged in an economic activity, with a legal form i.e. registered as a

business either with an Udyog Aadhar Number, or registration with Local District Industries Centre/SSI/MSME Directorate or with a free trade/industrial zone/export zone in India.

- The enterprise must be a for-profit business and profit making in the period for which its being evaluated.
- The enterprise must be in existence in India for a minimum period of three years at the time of application.
- The enterprise must disclose audited financial statements for the past three years for the purpose of screening and follow-up application.
- Once shortlisted for evaluation, the enterprise must be open to discussions, interviews, site visits and must furnish supporting details as and when required, etc.

AWARD CEREMONY
At the Axis Bank presents India SME 100 Awards evening, the top 100 SMEs chosen by the Jury of India SME Forum, shall be awarded in the Award ceremony evening to be held in Delhi in the presence of a galaxy of leaders, policy makers and well wishers of the Indian MSME community.

As on March 1, a total of 21024 nominations have been received from SMEs all over India and will be evaluated to find the TOP 100 SMEs of India, as per the process established. With the Nominations closing on April 16, 2016, make sure you should send in your nomination today.
